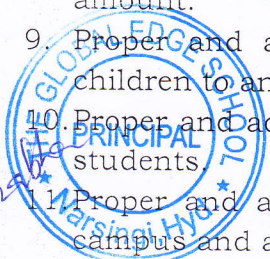

The Sri.M.Baga Reddy Educational Society has applied for according permission to open classes VIII (E.M), The Global Edge School, in locality of Narsingi, Gandipet(M), Rangareddy Dist.

The District Educational Officer, Rangareddy Dist has caused inspection and submitted the report in the reference 2<sup>nd</sup> cited.

In view of the above the Management of The Global Edge School,, Narsingi, Gandipet(M), Rangareddy Dist is permitted to start the school with classes VIII (E.M) at a stretch during the year 2019-2020.

1. That the society shall be abide to the rules and regulations made in the Govt. orders 5<sup>th</sup> cited above.
2. That the Society shall provide the necessary amenities like accommodation sanitary facilities, drinking water facilities, Furniture, Library, Laboratory, equipment play field required staff as per the staff pattern and other facilities before approaching the competent authority.
3. That the Society shall apply for recognition by immediately at the latest duly fulfilling the conditions.
4. That the permission is accords is restricted to this year only and it is not valid for the subsequent academic year.
5. That this permission does not confer any right on the society for claiming recognition.
6. That the permission is accorded to the Sri.M.Baga Reddy Educational Society /Trust and no other society/Trust of body can open a school on their behalf.
7. The permission is accorded to open to the school permission in the locality there shall not be a change in the premises of locality.
8. The society shall provide the necessary material even if it is costs more that the deposit amount.
9. Proper and adequate parking area for vehicles shall be provided transporting the children to and for the school.
10. Proper and adequate sanitation facility shall be provided for students especially for girl students.
11. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.

12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
13. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
14. The school shall have first aid kit and the teachers shall be trained in first aid.
15. The above permission is accorded purely on a temporary basis and is subjected to the reports of State Level Inspection and Vigilance Committee fulfilling of all the perquisite condition under the A.P Education Act 1982 and if later found that the school has not fulfilled any perquisites as stipulated, the permission now being given is liable to be withdrawn at once.
16. The permission is accorded for classes VIII (E.M) with single sections only (Each class) and further the management shall have no right to put any branches with this permission order.
17. The Management has to follow the Government norms from time to time, for collection of fee from students.
18. Subject to condition of the Structural Soundness of the building by E.E (R&B) or E.E (P.R) and Sanitary Certificate from DMHO (or) Sanitary Inspector before applying for recognition.

Such Report shall be supported by the audited statement of accounts of the school duly audited by a Chartered Accountant.
- The School Management shall upload their school information in the web site of the State School Education department including their fees details and other required information useful to the parents.
- The Management should follow the provisions of the Telangana Education Act, 1982; G.O.Ms.No.1, Education (PS.2) Department, dt.01.01.1994, as amended from time to time and Compulsory Teaching and Learning of Telugu as per the provisions of the Act No.10 of 2018, dt.30.03.2018, which came into force from 02.04.2018 and the connected Rules to this Act issued vide G.O.Ms.No.15, School Education (Prog.II) Department, dt. 01.06.2018. The Government have also prescribed the books to be introduced for Classes I and VI which have to be followed for the Compulsory Teaching & Learning of Telugu language as per this Act 10 of 2018 & the connected Rules.
